PREFACE

Mr. Speaker Sir, pursuant to the provisions of the Standing Order no 45 (2) (c), on the 13th day of July 2021, Hon. Salome Gathoni Kamau sought a statement from the Chairperson, Committee on Agriculture, Livestock and Fisheries Development on the status of the status of Ol Kalou abattoir and all other abattoirs in the County.

The statement was in the following terms;

Aware that the Part II of the Fourth Schedule of the Constitution of Kenya mandates the Counties with the function of County abattoirs; refuse removal, refuse dumps and solid waste disposal; and care and burial of animals;

Further aware that article 43 of the Constitution guarantees every person a right to the highest attainable standard of health;

Noting that the House previously two years ago considered a statement on the state of abattoirs in the County and expressed displeasure on deplorable state of most of the abattoirs due to lack of adequate water and poor disposal of refuse and dead animals which includes disposal of inconsumable meat;

Further Concerned of the deplorable infrastructure or lack thereof including lack of fencing structures, ablution blocks and water services among others;

Arising from the foregoing, I seek that the Chairperson of the Committee on Agriculture, Livestock and Fisheries Development provides the following information:

- i. The status of the abattoir at OI Kalou Municipality and all other county abattoirs in terms of its operation, sanitation and revenue raised.
- ii. Whether the previous issues raised during the closure of OI Kalou Abattoir two (2) years ago were sufficiently addressed.
- iii. The status the court case involving Ol Kalou abattoir.
- iv. The annual financial turnover of all the abattoirs in the County.

CHAIRPERSON – AGRICULTURE, LIVESTOCK AND FISHERIES COMMITTEE

COMMITTEE PROCEEDINGS

Mr. Speaker Sir, on 14th July 2021, the Committee through the Office of the Clerk wrote to the County Executive Member for Agriculture, Livestock and Fisheries requesting for the following information:



- 1. The status of the abattoir at OI Kalou Municipality and all other county abattoirs in terms of its operation, sanitation and revenue raised.
- 2. Whether the previous issues raised during the closure of OI Kalou Abattoir two(2) years ago were sufficiently addressed.
- 3. The status the court case involving Ol Kalou abattoir.
- 4. The annual financial turnover of all the abattoirs in the County.

On 22nd July 2021, the County Executive Member for Agriculture, Livestock and Fisheries responded in writing through the Office of the Clerk with the requested information. The same was referred to the committee so as to compile the statement response. During a Committee of the Whole House exercise held between 9th -12th February, 2022, the committee considered the submissions and came up with a statement response.

STATEMENT RESPONSE

1. The status of the abattoir at the Ol'kalou Municipality and all other County abattoirs in terms of operation, Sanitation and revenue raised.

Nyandarua County has a total of seventy-one (71) slaughter houses. It is only three slaughter houses; Mirangine, Olkalou and Miharati that are owned and managed by the County Government of Nyandarua. They were inherited from the defunct local Government. The other slaughter houses are owned by the private investors.

The three County slaughter houses are currently operating smoothly. Each slaughter house has a meat inspector deployed to carry out veterinary public health services and casual laborer to carry out the manual duties.

They all have blood tank, condemnation pit and Manure yard for waste disposal. Olkalou and Miharati Slaughter house have piped water while Mirangine slaughter house has a shallow well.

(a) Revenue Raised by Olkalou Slaughter house

Total Revenue collected = Meat inspection + COT + Inspection fee

= Ksh (584,050+14,020+ 267,600)

= Ksh 865,670/=

2. Whether the previous issues raised during the closure of Ol'kalou Abattoir two (2) years ago were sufficiently addressed.

The issues raised were not addressed because the area MCA and the members of Agriculture committee agitated for the opening of the slaughter house despite it having been closed by NEMA. This was done during a stakeholder meeting held on November, 2019.

The abattoir sits on a small area of less than a quarter acre and is within the riparian reserve. Olkalou Municipality had promised to relocate the abattoir but it is taking too long. The operations and maintenance of this abattoir should be carried out by the Municipality while the Department of Agriculture, Livestock and Fisheries plays it regulatory role in ensuring food safety.

There is no future of this abattoir because the construction of Olkalou Sewerage System will compromise the hygienic condition. A section of trunk sewer will be constructed next to the abattoir.

There are other private slaughter houses within the municipality that can serve the community in Olkalou town before a lasting solution is found.

3. The Status of the court case involving the Ol'kalou Abattoir.

The Department is not aware of any court case.

4. The annual financial turnover of all the abattoirs in the County.
